

# TERMS OF PARTICIPATION FOR ATHLETES (ISSUE 1/6/2025)

## 1. General Terms of Participation

- a) The parents/guardians of the athletes bear full responsibility for their arrival and departure from the facilities as well as from the other activities of the Academy, at the specified times as announced by Eurohoops Academy.
- b) Parents/quardians are not allowed to remain within the court during practice hours.
- c) Any change in training or game time will be communicated to the parents/guardians and athletes via the MyTeam app, email (as declared in the registration form), or the official Eurohoops Academy website (eurohoopsacademy.net).
- d) Every athlete registered with the Academy is required to obtain the necessary athletic equipment in order to participate normally in the activities. For the 2025–2026 competitive season, the Academy will proceed with a complete renewal of equipment; therefore, all athletes must purchase the new equipment set upon registration or re-registration.
- e) Eurohoops Academy bears no responsibility for any loss of items or clothing; athletes should avoid bringing valuables or large amounts of money.
- f) The operation schedule of Eurohoops Academy within the Arsakeio-Tositseio School may be modified according to decisions of the school administration (events, holidays, room usage). In such cases, the Academy will timely inform parents/guardians of any changes.
- g) Vehicle parking within Arsakeio-Tositseio School premises is permitted exclusively in areas designated by the school administration and Eurohoops (Parent Parking left of the main entrance). Parking outside the courts may be revoked at any time, especially for safety reasons (e.g., evacuation plans, fire safety, etc.).
- h) Athletes and their companions are allowed to use only the areas allocated to Eurohoops by the school. Use of or presence in unauthorized areas is prohibited. Responsibility for participants' safety is strictly limited to the approved and supervised training spaces. Eurohoops and the school bear no responsibility for activities outside these areas. Pets are not allowed anywhere in the facilities, indoors or outdoors.
- i) Entry of athletes for training at the elementary school court is only through the designated external gate for Eurohoops Academy. Entry through the main school building is forbidden. A designated area is available for parents/guardians during training. Entry or presence in other areas of the school, such as hallways or classrooms, is strictly prohibited.



# 2. Subscription - Athletic Equipment

The Eurohoops Academy subscription is monthly concerning the 2025-2026 season and consists of the following:

## 2.1 Monthly Training Subscription

The monthly subscription covers the full training program from September to June (10 months). Payment is due by the 5th of each month and is a prerequisite for participation in Academy activities.

No refunds will be provided.

## 2.3 Re-registrations

Applies to athletes registered in 2024-2025. Re-registration cost includes mandatory age-appropriate new equipment for the 2025-2026 season. For 2016-born athletes who already have the warmup gear, the cost is 165 euros.

## 2.4 New registrations



Includes mandatory equipment for all divisions:

- For athletes born between 2010 and 2016: Training Double Face jersey, Game Double Face jersey, Warmup jersey, Tracksuit set and training backpack.
- For athletes born between 2017 and 2020: Training Double Face jersey, tracksuit set and training backpack.

Payment can be made in two installments (September & October 2025).

#### 2.5 Subscription cost

Monthly subscription cost is determined as follows:

#### 2.6 Special discounts

15% discount on monthly fees for the 2nd and 3rd family member.

## 2.7 Payment terms

Monthly fees for the 2025-2026 season must be paid by the 5th of each month. Participation and financial commitment span ten (10) months (September to June). June's fee is paid together with May's.

Annual fee payments can be made in monthly installments:

- 1<sup>st</sup> installment → for the cost of registration/re-registration: September 2025
- 2<sup>nd</sup> installment→ 1/10 of the total annual subscription: between 1-5 September 2025
- $3^{rd}$  installment  $\rightarrow 1/10$  of the total annual subscription: between 1-5 October 2025
- 4<sup>th</sup> installment→ 1/10 of the total annual subscription: between 1-5 November 2025
- $5^{th}$  installment  $\rightarrow 1/10$  of the total annual subscription: between 1-5 December 2025
- $6^{th}$  installment  $\rightarrow 1/10$  of the total annual subscription: between 1-5 January 2026
- $7^{th}$  installment  $\rightarrow 1/10$  of the total annual subscription: between 1-5 February 2026
- $8^{th}$  installment  $\rightarrow 1/10$  of the total annual subscription: between 1-5 March 2026
- 9<sup>th</sup> installment  $\rightarrow$  1/10 of the total annual subscription: between 1-5 April 2026
- $10^{th}$  installment  $\rightarrow 1/10$  of the total annual subscription: between 1-5 May 2026

Payment methods: bank deposit, debit/credit card (POS), or cash at the Eurohoops Academy office.

In case of bank transfer, the payer should fill in the name of the athlete in the description of the deposit.

## 2.8 Subscription termination

a) In case of a decision to terminate the subscription the athlete or their parent/guardian must inform the Academy in writing via email at academy@eurohoops.net. Provided that the registration fee and monthly subscription have been fully paid and there are no outstanding financial obligations up to and including the month of withdrawal, Eurohoops Academy will proceed with deregistering the athlete as requested by them or their parent/guardian.

In the case of subscription termination after the midpoint (February) of the sports season, the athlete is required to pay the subscription fees for two (2) additional months beyond the already-paid month of withdrawal.

- b) If the athlete or their parent/guardian does not notify in writing via email at academy@eurohoops.net of the decision to withdraw. The athlete will remain registered with Eurohoops Academy, regardless of their absence or the duration thereof from its activities, and will be liable to pay the applicable subscription fees as stated above.
- c) For every athlete withdrawal, Eurohoops Academy reserves the right to replace the withdrawn athlete with a new one. An athlete who has been withdrawn cannot re-enroll within the same sports season. In the event of a request to re-enroll in a subsequent sports season, the athlete is required to pay the subscription for one (1) additional month beyond the already-paid month of withdrawal, provided that the original subscription termination occurred before the midpoint (January) of the sports season.
- d) In the case where an athlete has not been officially withdrawn from Eurohoops Academy, but is unwilling or unable to participate in training for any period of time, for reasons other than those described in Article 3, they are not exempt from the obligation to pay the subscription fees for the duration of their absence.
- e) Failure to pay the aforementioned subscription amounts within the specified deadlines gives Eurohoops Academy the right to immediately and without notice terminate the contract for the provision of sports services to the athlete and proceed with their immediate deregistration.

#### 3 Medicals

- a) Every athlete wishing to participate in Eurohoops Academy is required to undergo a cardiology examination and to submit an athlete health card.
- b) Training sessions and home games held at our facilities are conducted in the presence of staff trained in First Aid. A doctor will also be present during Eurohoops Academy games held at the Leonteios School facilities. Therefore, Eurohoops Academy cannot be held responsible for any injury or other incident occurring within the scope of its activities, nor for covering any related medical expenses. Eurohoops Academy also bears no liability for any direct or indirect damage, moral harm, or emotional distress suffered by the athlete.
- c) In the event that an athlete is absent from Eurohoops Academy activities due to injury or illness,



they are still required to pay the subscription fee for that period.

#### 4 Deregistration from Eurohoops Academy for Disciplinary Reasons

- a) In the event of inappropriate behavior by a parent/guardian of an athlete Eurohoops Academy reserves the right to remove them or prohibit them from attending training sessions or games. Inappropriate behavior is defined as any act or omission that is not aligned with the philosophy of Eurohoops Academy. This includes, but is not limited to, conduct in the stands, attitude toward other parents of athletes (from Eurohoops Academy or other clubs), and behavior toward coaches, staff, or third parties.
- b) Non-compliance by a parent/guardian with the rules or the instructions of Eurohoops Academy staff may result in the immediate deregistration of their athlete from the Academy without prior warning and without any obligation to refund the subscription or provide any other compensation.

#### 5 Audiovisual Material and Intellectual Property

- a) Any kind of photography, video recording, or audio recording is strictly prohibited within the facilities without the permission of Eurohoops Academy.
- b) By registering the athlete, you consent to the use and exploitation by Eurohoops Academy and the company "Eurohoops Greece IKE" of any audiovisual material that includes your minor child, created within the scope of their participation in the Academy's activities. By completing the "Athlete Participation Application" form, the guardian automatically provides consent for the storage in electronic format and the use of audiovisual material that includes the athlete, as per paragraph 7 above, in the context of their games or training sessions. This material may be used: (a) By Eurohoops Academy staff to monitor the athlete's performance, (b) For online publication (on the official website or on the social media accounts of Eurohoops Academy and its affiliated companies—e.g., partners, sponsors, etc.). This data may be processed for up to twenty (20) years after the termination or expiration of the corresponding agreement, to ensure that material exists for a potential long-term progress video of the athlete.

#### 6 Personal Data

# 6.1 Identity Information, Birth Certificate, Photographs

In execution of the sports services contract, Eurohoops Academy will maintain both electronic and written records of the athlete's and guardian's information as provided in the "Athlete Participation Application" form. This data is collected to facilitate communication with the athlete and/or their guardian when needed (e.g., in the case of schedule changes for training sessions, matches, etc.). In this context, a written and possibly electronic copy of the submitted birth certificate will be kept to clearly verify the athlete's date of birth, to ensure proper placement in the appropriate age group, and to confirm eligibility for participation in age-specific competitions. Additionally, a written and electronic file of the athlete's photographs will be maintained so that, in execution of the relevant contract, the athlete can always be identified (e.g., recognized by coaches, etc.). Finally, records will be kept regarding the days and hours of the athlete's participation in sports activities,



as well as their athletic performance during games and/or training (specifically, statistical performance data such as playing time, successful/unsuccessful shots, etc.). However, no biometric data will be collected under any circumstances. The above data will be retained for a period of up to five (5) years following the termination or expiration of the relevant contract. The only exception to this rule concerns statistical data, which will be retained indefinitely in order to preserve a historical record of both team and individual performance statistics.

#### 6.2 Medical certificates

Eurohoops Academy will maintain both written and electronic records of the athlete's health card, which is submitted during the conclusion and/or renewal of the sports services contract. This processing is necessary to protect the athlete's vital health interests and also constitutes a legal obligation for Eurohoops Academy. This data will be retained for up to five (5) years after the termination or expiration of the relevant contract. The data is securely stored in protected physical and electronic formats, in accordance with applicable data protection laws.

## 6.3 Electronic Updates on Eurohoops Academy News and Activities

By completing the "Athlete Participation Application" form, the athlete's guardian automatically consents to receiving email updates and promotional content related to Eurohoops Academy's news and activities, sent to the email address provided in the application. This processing will also continue for up to five (5) years following the termination or expiration of the contract.

#### 6.4 Additional information

Eurohoops Academy implements appropriate technical and organizational security measures to protect personal data against loss, alteration, unauthorized access, or disclosure, in accordance with data protection legislation.

The guardian or the athlete (subject to applicable legal conditions) has the right to submit a request at any time to Eurohoops Academy for access and correction or deletion of the aforementioned data or restriction of processing, or objection to processing, or data portability (transfer of data to a third party). They also have the right to file a complaint with the competent authority if they believe their personal data rights have been violated. It is clarified that the data categories in sections 6.1, 6.2, and 6.3 are essential for the execution of the sports services contract.

No automated decision-making or profiling of the athlete will take place during this processing. Certain data may be disclosed to third-party recipients, specifically: Basketball authorities, as required by official regulations (e.g., to the organizing authority "ESKA"), opponent teams, only when required by relevant rules and only for regulatory compliance. Under no circumstances will this data be transferred to third countries outside the EU or to international organizations.

The registered office of the Data Controller is located at 10 Triantafyllidi Street, Athens, Attica. The legal representative of the Data Controller is the Chairman of its Board of Directors, Mr. Andreas Athanasiadis, son of Pericles.
