



Terms and conditions for participation in Easter camp 2026 (version 28/2/2026)

I. General terms

- This document incorporates the terms of the contract between the athlete (represented by his/her guardian) and the sports club named "Exelixis Ακαδημία Καλαθοσφαίρισης Αθλητικό Σωματείο " based in Kifissia, Attica (35 Pigeon Street, 14564) as legally represented (Eurohoops Academy) for the provision of basketball sports services (training services) by Eurohoops Academy to the athlete for the selected period of time mentioned below.
- It is certified that the athlete is in good health and is deemed capable of participating in intensive sports activities, as evidenced by the Sports Fitness Certificate that must be submitted before the athlete begins participating in these activities.
- The amount corresponding to each participation must be deposited into the account below or paid at the court's office without exception, at least 7 days before the start of the selected period.
- All participants must comply with and adhere to the Camp rules.
- Failure to accept the terms of participation or to sign the Athlete Participation Application - Easter Camp 2026, or failure to submit the documents referred to therein, or failure to pay the relevant participation fee in accordance with these terms, means non-participation.

If the participant withdraws after the contract has been drawn up, they are entitled to a refund of the amount paid, with the exception of start-up and organization costs (15% of the total participation fee). In case of withdrawal during the Camp, the organizer is not obliged to refund any money.
- Parents/guardians are not allowed to attend the athletes' training sessions.
- By submitting my details and accepting my child's participation in the Camp, I declare that I fully and unreservedly accept the terms and conditions herein.

Members of the Eurohoops Academy for the 2025-2026 season receive a 10% discount on the original price, and in the case of family participation, the second member receives a 15% discount, while the third member receives a 20% discount.

In the case of family participation, the second member receives a 10% discount and the third member a 15% discount.

Parents who wish to do so may, at an additional cost, extend their children's stay for childcare at the Arsakeio Tositsio facilities on the dates 6-9/4 and 14-17/4: 8-10 a.m. and 2-5 p.m. at a cost of €10+€10.

IV. Personal Data

IV.1 Personal Data: In accordance with the contract for the provision of sports services, Eurohoops Academy will keep the athlete's and guardian's details in electronic and written form, as stated in the "Athlete Participation Application – Easter Camp 2026" form. This information will be collected in order to facilitate communication with the athlete and his/her guardian as necessary (e.g., in the event of a change in the training schedule, childcare, etc.).

IV.2 Finally, records will be kept regarding the days and times of the athlete's participation in sports activities and their athletic performance during training (in particular, statistical athletic performance data, such as successful/unsuccessful shots, etc.), but under no circumstances will biometric data be kept. This data will be kept for a maximum period of five (5) years from the termination/expiration of the relevant contract.

IV.3 Sports Fitness Certificate: Eurohoops Academy will keep a paper and electronic record of the participant's Sports Fitness Certificate, which provided upon conclusion and/or renewal of the contract for the provision of sports services. This processing is necessary to protect the vital health interests of the Athlete and is also a legal obligation of Eurohoops Academy. This data will be kept for a maximum period of five (5) years from the termination/expiration of the relevant contract.



IV.4 Audiovisual Material: The athlete's guardian, by completing the form By submitting the "Athlete Participation Application," the athlete automatically gives their consent for the electronic storage and use of audiovisual material in which they participate during training. This material may be used: (a) for monitoring by Eurohoops Academy staff of the athlete's athletic performance, (b) for publication on the internet (on the official website or social media pages of Eurohoops Academy). This processing will be carried out for a maximum period of ten (10) years from the termination/expiration of the relevant contract, so that in the event that a video is created to document the athlete's progress over the years, the relevant file will be available. The Guardian or the athlete himself, under the conditions of the relevant legislation, may revoke his consent by simply notifying Eurohoops Academy.

IV.5 Electronic updates on Eurohoops Academy news and activities and messages from eurohoops.net: The athlete's guardian will choose, at their sole discretion, on the "Athlete Participation Application - Summer Camp 2025" form whether to give their consent for the email address they provided on the form to be used for sending information about Eurohoops Academy and eurohoops.net news and activities, i.e. to the company "Eurohoops Greece IKE" located at 24 Eurota Street, Kifissia, Greece, with GEMI number 141930201000 (which may also include messages from their sponsors). This processing will be carried out for a maximum period of five (5) years from the termination/expiration of the relevant contract. The Guardian may revoke his/her consent by simple statement to Eurohoops Academy.

IV.6 Other information: The Guardian or the athlete himself, under the conditions of the relevant legislation, has the right to submit a request to Eurohoops Academy at any time for access to and correction or deletion of the above data, or for restriction of processing, or to object to it, or for portability (transfer) of the data to a third party. In any case, the Guardian or the athlete himself have the right to lodge a complaint with any competent authority for any violation of the provisions in force in relation to their personal data. It is clarified that the data referred to in paragraphs IV.1, IV.2, and IV.3 above are necessary for the performance of the service contract. In the context of the processing of the above data, no automated decision-making and/or profiling of the athlete will take place. The data under IV.4 above (i.e., the email addresses of guardians) Under no circumstances will any of the above data be transferred to a third country (outside the EU) or to an international organization. With regard to the above, it is clarified that Eurohoops Academy is the Data Controller. The complete and accurate Its name is "Exelixis Basketball Academy Sports Club" and its contact details are listed below. Training sessions and the main sports facility are located in Anoixi, Attica (1 Marathonos Street), where any notification or request can be made, etc. The legal representative of the Data Controller is the Chairman of its Board of Directors, Mr. Andreas Athanasiadis of Pericles.
