

# Terms of Participation – Summer Camp 2026

Date: 06/04/2026

## I. General Terms

- This document constitutes the agreement between the athlete (represented by their legal guardian) and the sports club under the name "Exelixis Basketball Academy Basketball Athletic Club," based in Kifisia, Attica (35 Pigon St, 14564), as legally represented (Eurohoops Academy), for the provision of basketball sports services (coaching services) to the athlete for the selected period specified below.
- It is certified that the athlete is in good health and deemed fit to participate in intensive sports activities, as evidenced by the Medical Fitness Certificate (*Deltio Katallilotitas Athlisis*), which must be submitted before the start of participation.
- The participant takes part in sports activities at the responsibility of their guardian, who acknowledges the nature of the athletic activity and the potential risks of injury. The organizer bears no responsibility for injuries that may occur during the normal course of training, except in cases of intent or gross negligence.
- The amount corresponding to the respective participation must be deposited into the account below or paid at the court's reception desk without exception, at least 7 days prior to the start of the selected period.
- Every participant must comply with and adhere to the Camp rules.
- Failure to accept the terms of participation, failure to sign the "Athlete Participation Application – Summer Camp 2026," failure to submit the required documents, or failure to pay the required fee according to these terms results in the non-conclusion of the contract, without any claim on the part of the participant. If a participant withdraws after the contract is finalized, they are entitled to a refund of the amount paid, excluding startup and organization costs (15% of the total participation fee). In the event of withdrawal during the Camp, the organizer is not obliged to issue a refund.
- Parents/guardians are not permitted to be present during athlete training sessions.
- By submitting my details and accepting my child's participation in the Camp, I responsibly declare that I fully and unreservedly accept the terms herein.
- The organizer bears no responsibility for the non-execution or modification of the program due to Force Majeure (e.g., extreme weather events, strikes, health crises, government decisions).

## II. Summer Camp 2026 Participation Costs

**For consecutive weeks: -5% off**

For Eurohoops Academy members during the 2025-2026 season, a 10% discount is provided on the original price and in case of family participation, the second member receives a 15% discount, and the third member receives a 20% discount. In case of family participation for non-members of the Academy, the second member receives a 10% discount and the third member receives a 15% discount. Parents may extend their children's stay at the Arsakeia-Tositseia facilities for the hours 08:00–10:00 and 14:00–17:00 at an additional cost of €10 + €10.

### III. Payment Methods

Payment must be made via bank deposit, debit/credit card (POS), or cash at the Eurohoops Academy reception. For bank deposits, the depositor is requested to include the athlete's name in the transaction description. A spot is considered reserved only after full payment. A copy of the payment receipt must be sent to the Academy.

### IV. Personal Data Protection (GDPR)

**IV.1 Personal Data:** For the execution of the contract rendering of athletic services, Eurohoops Academy will maintain the athlete's and guardian's data in electronic and hard copy form as stated in the application. This data collection process is for communication purposes only between the Academy and the athlete or the guardian (e.g., schedule changes).

**IV.2** In conclusion, records of attendance and athletic performance (e.g., shooting statistics) will be kept for up to five (5) years after the end of the contract. No biometric data will be stored.

**IV.3 Medical Fitness Certificate:** Eurohoops Academy will keep the medical certificate of the athlete for up to five (5) years until the end of this contract. This processing is necessary for the vital health interests of the Athlete and furthermore it forms part of the legal obligation of Eurohoops Academy.

**IV.4 Audiovisual Material:** By signing the application, the guardian consents to the storage and use of audiovisual material (photos/videos) featuring the athlete during practice. This content will be: (a) for the monitoring of the athlete's performance by Eurohoops Academy staff, (b) for online publication (on the official website or social media pages of Eurohoops Academy). The said processing will be continuing for the duration of (10 years) at last, from the end of this contract, so that the athlete could have access to this content about the evolution of him during the years. The legal guardian or the athlete themselves under legal conditions may withdraw their consent by a simple statement to Eurohoops Academy.

**IV.5 Electronic Updates for the news and the activities of Eurohoops Academy and for direct messages from eurohoops.net:** The guardian of the athlete in the Athlete Participation Application – Summer Camp 2026 document can decide whether to receive newsletters regarding Eurohoops Academy and Eurohoops.net «Eurohoops Greece IKE» located at 24 Evrota St, Kifisia, with GEMI (General Commercial Registry) number 141930201000 (which may also include messages from their sponsors). This process will continue up to 5 years and the legal guardian or the athlete themselves under legal conditions may withdraw their consent by a simple statement to Eurohoops Academy.

**Other information:** The guardian or the athlete himself under its conditions of relevant legislation has the right to submit to Eurohoops Academy at any time request for access and correction or deletion of the above data of or for limitation of the processing or for his opposition to it or for the portability (transfer) of them data to a third party. In any case, the guardian or the athlete himself have the right to complain before any competent authority for any violations written provisions in relation to their personal data. It is clarified that as above, the items under par. IV.1 IV.2 and IV.3 are necessary for the execution of the contract provision of services. In the context of the processing of the above data, it will not be received by the country's automated decision-making and / or profiling of the athlete. The data under items IV.4 above (ie the email addresses of the guardians). All of the above data will not be transmitted under any circumstances to a third country (outside the EU) or internationally. With reference to the above, it is clarified that Eurohoops Academy is the Responsible for Data Processing. Its full and exact name is "Eselixis Basketball Academy Sports Club" and its contact details are listed below. The training and the main sports area are located in Anoixi Attica (street. L. Marathon 1), where any notification or request can be made or one can be submitted.
