



Terms of Participation

I. General Terms

- a) Athletes' parents/guardians are solely responsible for both arrival and departure from the facilities as well as for their arrival and departure from the rest of the activities at the Academy, during a specific timetable announced to them by Eurohoops Academy.
- b) Parents/guardians are not allowed to remain on the field during training hours.
- c) Any change to the training or match schedule will be communicated to the athletes and their parents/guardians via the Myteam app, via email (using the details provided in the registration form), or through an announcement on the official Eurohoops Academy website (eurohoopsacademy.net).
- d) Athletes are required to have the necessary sports equipment to participate in the Academy's activities.
- e) Eurohoops Academy bears no responsibility for the loss of athletes' personal belongings or clothing; athletes should avoid bringing valuables or large sums of money with them.
- g) The operating schedule of the Eurohoops Academy within the Arsakeios-Tositsei School may be modified based on the decisions of the school administration (events, holidays, classroom needs). In such cases, the Academy will promptly inform parents/guardians of any change.
- h) Parking of vehicles on the grounds of the Arsakeia -Tositseia Schools of Ekali is permitted exclusively to parking points designated by the school administration and Eurohoops (the parents' parking is located to the left of the main entrance). The possibility of parking outside the courts can be revoked at any time, especially for safety reasons (e.g. evacuation plans, fire safety etc.).

i) Athletes and their guardians are only allowed to use the spaces they have granted to Eurohoops by the Arsakeia-Tositsia Schools. The activities and even the stay in unbounded spaces are not allowed. Responsibility for the safety of participants is solely limited to approved and supervised training areas. For any activity other than these, the Arsakeia -Tositsia Schools and Eurohoops bear absolutely no responsibility. In addition, it is prohibited to enter pets, both indoors and outdoors.

j) The entrance of the athletes for the training in the Elementary school field (Court 3) is exclusive from the outside door, designated as the only entrance to the facility for Eurohoops Academy use. Entry through the main school building is prohibited. There is a specially designed area in which parents/guardians can remain during training. It is prohibited strictly to enter and stay in other areas of the school, as well as any visit in corridors or classrooms.

2. Subscription

The subscription to Eurohoops Academy is for ten months and covers the entire 2026-2027 season (1 September, 2026 – June 30, 2027) and its payment is mandatory for its total duration. It is possible to pay the total subscription in monthly installments, as described below, without negating the ten-month duration of the subscription. No refunds for any reason.

2.1 Monthly subscription for training participation

The monthly subscription payment for the 2026-2027 period must be paid strictly by the 5th day of every month. The total duration and economic obligation amounts to (10) months from September until June. Note that the subscription for June should be paid with the subscription of May.

2.3 RE-ENROLLMENTS

Applies to athletes who were registered with the Eurohoops Academy and the 2025-2026 season. The re-registration fee includes the mandatory age-specific sports equipment of the 2026-2027 season. The cost for athletes born in 2017 who have already purchased the warmup is 95 euros.

2.4 NEW REGISTRATIONS

The cost includes the sports equipment which is mandatory for all ages:

- For athletes born in 2009 to 2017: DoubleFace training, DoubleFace Race, Warmup, Form Set and training backpack.
- For athletes with year of birth 2018 to 2021: DoubleFace training, Uniform Set and backpack training.

The payment of the sports equipment can be made in two installments (September - October 2026).

2.5 Cost of registration

In detail, the monthly subscriptions are configured as shown in the table below:

2.6 Special discounts

- In case of family registration the 2nd and 3rd member get a 15% discount on the monthly subscription.
- The one-time payment of the annual subscription and registration until the end of September 2026 is accompanied by a 5% discount and it is possible to pay with a credit card in up to 12 interest-free installments.

Payment must be made via bank deposit or debit/credit card (POS) registered at the Eurohoops Academy secretariat. In case of payment by bank deposit the depositor is requested to fill in the athlete's name in the justification of the deposit.

2.7 Termination of Subscription

a) In the event of a decision to stop membership, the athlete or his parent/guardian must inform in writing via e-mail to academy@eurohoops.net. If and when he has paid the fee in full registration and his monthly subscription and does not have any financial outstandings until the end of the month of his deletion, Eurohoops Academy will delete him as decided by him or his parent/guardian. In case of termination of membership after the middle (February) of the competition season, it is requested to pay the subscription for two (2) additional months.

b) If the athlete or their parent/guardian does not provide written notification of the decision to withdraw via email to academy@eurohoops.net, the athlete will remain registered with Eurohoops Academy regardless of their absence from its activities or the duration thereof (and will be liable for the corresponding membership fees mentioned above).

c) For each athlete deletion, Eurohoops Academy reserves the right to replace him with a new one. The athlete who got deleted, does not have the right to re-register within the same competition season. In case of a re-registration request in the next competition season, the athlete is obliged to pay the subscription of one (1) additional month, from the already paid month of

deletion, if its interruption subscription had taken place before the middle (January) of the competition season.

d) In the event that an athlete has not been deleted from the Eurohoops Academy, but does not wish to or does not may, for other reasons, train for any period of time that is not excluded from the obligation to pay the subscription for the period of his absence.

e) Non-payment of the above subscription amounts within the above deadlines provides Eurohoops Academy the right to terminate the contract for the provision of sports services immediately and without observing a deadline to the athlete and his immediate deletion.

3. Health

a) Every athlete who wishes to participate in the Eurohoops Academy is required to undergo an examination by a Cardiologist, and on presentation of the athlete's health card.

b) Eurohoops Academy training sessions and home games held at the facilities take place in the presence of staff trained to administer First Aid. Consequently, Eurohoops Academy cannot be held liable for any injury or other incident occurring during its activities, nor for the coverage of any subsequent medical expenses. Furthermore, Eurohoops Academy bears no liability for any direct and/or consequential damages, moral harm, or emotional distress suffered by its athletes.

c) In the event of the athlete's absence from Eurohoops Academy activities due to injury or illness, they are not exempt from the obligation to pay the fee.

4. Deleted from Eurohoops Academy for Disciplinary Reasons

a) In case of indecent/offensive behavior of a parent/guardian, Eurohoops Academy retains the right to remove and ban him from entering the stadium. Eurohoops Academy has absolute discretion to define conduct as indecent/offensive.

b) Non-compliance of the parent/guardian with the regulations or the instructions of the Eurohoops staff Academy may remove its athlete from its ranks without notice and without The right for refund of the subscription or other compensation.

5. Audiovisual Material and Intellectual Property

5.1 Any kind of photography, video recording or sound recording is prohibited in the facilities without the permission of Eurohoops Academy.

5.2 By registering the athlete you consent to the use and exploitation by Eurohoops Academy and the company “Eurohoops Greece IKE” of any audio-visual material related to your minor child as it arises in the context of its activities in it.

5.3 The Athlete's Guardian by completing the "Athlete Participation Application" form automatically provides his consent to the electronic retention and use of audio-visual material in which he will the athlete participates according to the above paragraph, in the context of his and/or others' competitions or trainings activities of the Academy.

5.4 Such material may be used: (a) for monitoring by Eurohoops Academy staff, of the sports performance of the athlete, (b) for publication on the internet (on the official site or on social networking pages of Eurohoops Academy and its partner companies. The one in question processing will be carried out for a maximum period of twenty (20) years from the termination / expiration of the relevant contract so that in case there is the possibility of creating a video about his progress over the years, there is the relevant file.

6. Personal Data Protection (GDPR)

6.1 Identity Details, Birth Certificate, Photographs:

For the execution of the contract rendering of athletic services, Eurohoops Academy will maintain the athlete's and guardian's data in electronic and hard copy form as stated in the application. This data collection process is for communication purposes only between the Academy and the athlete or the guardian (e.g., schedule changes).

In this regard, a document and possibly an electronic file of the presented certificate will be kept date of birth to easily demonstrate the date of birth of the athlete, his/her correct membership in the relevant age division of sports and possibly his legal participation in the appropriate age divisions race categories. A document and electronic file of the athlete's photos will also be kept so that in execution of the relevant contract, it is always possible to identify him (recognition by the coaches etc). Finally, a record will be kept regarding the days and hours of the athlete's participation in sports activities and with his sports performance in the context of competitions and / or trainings (in particular statistical sports performance data, such as participation time, hit/miss shots, etc.), however, biometric data are not kept under any circumstances. The observance of the above data will be done for a maximum period of five (5) years from the termination / expiration of the relevant contract. They are an exception to this only the Statistics, where they are kept there indefinitely so that the historicity of its statistics exists team and player.

6.2 Medical Fitness Certificate:

Eurohoops Academy will keep the medical certificate of the athlete for up to five (5) years until the end of this contract. This processing is necessary for the vital health interests of the Athlete and furthermore it forms part of the legal obligation of Eurohoops Academy.

6.3 Electronic Updates for the news and the activities of Eurohoops Academy and for direct messages from eurohoops.net:

The Parent/Guardian, by completing the "Athlete Participation Application" form, automatically provides his consent to send, via e-mail, informative material in relation to its news and actions Eurohoops Academy. This processing will be carried out for a period of up to five (5) years from filling out the form above.

6.4 Other information:

Eurohoops Academy takes appropriate technical and organizational security measures to protect their personal data from loss, alteration, unauthorized access or disclosure, pursuant to the standards of the applicable data protection legislation.

The Guardian or the athlete himself under the conditions of the relevant legislation has the right to submit at any time to Eurohoops Academy a request for access and correction or deletion of the above of his data or to limit the processing or to object to it or for the portability (transfer) of them data to a third party. In any case, the Guardian or the athlete himself has the right to complain before any competent authority for any violation of the written provisions in relation to their personal data. It is clarified that from the above the elements under par. 6.1, 6.2 and 6.3 are necessary for the performance of the service contract. The processing of the above mentioned data will not involve automated decision-making or profiling of the athlete. The data in question may be transmitted to third-party recipients—specifically, either to basketball sports authorities in compliance with relevant regulations (e.g., the organizing principle "ESKA") or to opposing teams—only when required by the applicable regulations. All of the above data will not be transmitted under any circumstances to a third country (outside the EU) or to an international organization. With reference to the above, it is clarified that Eurohoops Academy is responsible for data processing. Its full and accurate name is "Ekselixis Academy of Basketball Sports Association" and its contact details are listed below. The headquarters of the Controller is located at 10 Triantafyllidi Street, Athens Attica. The legal representative of the Data Controller is the Chairman of the Board of Directors, Mr. Andreas Athanasiadis of Pericleus.
