



Terms of Participation

Back to School Camp 2026

(έκδοση 25/6/2026)

I. General Terms

- This document incorporates the terms of the agreement between the athlete (represented by their guardian) and the sports club under the name "Exelixis Basketball Academy Sports Club," based in Kifisia, Attica (35 Pigon Street), as legally represented (Eurohoops Academy), regarding the provision of basketball-related sports services (training services) by Eurohoops Academy to the athlete for the selected period specified below.
- It is certified that the athlete is in good health and deemed fit to participate in intensive athletic activities, as evidenced by the Certificate of Athletic Fitness, which must be submitted prior to the commencement of their participation in said activities.
- Participation in the Eurohoops Camp is considered valid, and the participant's spot is secured, only after registration is completed.
- To complete the registration, either of the following is required:
 - a) payment of the total participation fee, or
 - b) payment of a deposit equal to 50% of the total participation cost.
- Full payment of the participation fee must be completed no later than seven (7) calendar days prior to the camp's start date.
- All participants are required to observe the Camp's operating rules.
- Failure to accept the terms of participation, to sign the Athlete Participation Application, to submit the documents specified therein, or to make the required advance payment in accordance with these terms results in the contract not being concluded, with no claim

arising on the part of the participant. Should the participant withdraw after the contract has been concluded but prior to the start of the Camp, they are entitled to a refund of the amount paid, less startup and organizational costs (15% of the total participation fee). In the event of withdrawal during the Camp, the organizer is under no obligation to provide a refund.

- Parents/guardians do not attend training sessions, in order to ensure the smooth conduct of the program and the athletes' concentration.
- By submitting the details and accepting the child's participation in the Camp, the guardian declares full and unconditional acceptance of the terms herein.

Discounts

- For participation in more than one consecutive period, a 10% discount per period applies starting from the second period.
- For family participation (Eurohoops Academy members), the following discounts apply:
 - ❖ 15% for the second member
 - ❖ 20% for the third member
- For family participation (non-Eurohoops Academy members), the following discounts apply:
 - ❖ 10% for the second member
 - ❖ 15% for the third member
- Discounts cannot be combined. If a participant is eligible for more than one discount, the highest discount applies to the original participation fee.
- Discounts do not apply to special packages, additional services, or programs with already reduced pricing, unless otherwise stated.

III. Insurance and Communication

Eurohoops Academy oversees the organization and safe conduct of all activities for the Eurohoops Camps | Back to School Edition 2026, ensuring that participants remain under the supervision of experienced and specialized staff at all times.

Access to the Camp facilities is restricted and permitted only for authorized individuals. Parents/guardians are not permitted to be present during training sessions, except on specially scheduled open days, should these be announced.

In the event of an emergency or a need to communicate, parents should contact the Eurohoops Academy team exclusively using the details provided upon registration. The Camp team ensures that parents are promptly informed of any incident concerning their child's health, safety, or general participation. Throughout the Camp, there is daily supervision and an organized system for managing minor injuries or other incidents that may arise. Participation in the Camp requires the submission of a Certificate of Athletic Suitability issued by a certified physician; this is a mandatory prerequisite for the athlete's participation in the activities.

IV. Personal Data Protection (GDPR)

IV.1 Personal Data:

For the purpose of executing the sports services agreement, Eurohoops Academy will maintain the details of the athlete and the guardian—as set out in the "Athlete Participation Application –

Back to School Camp 2026" form—in both electronic and hard-copy formats. These details are collected to facilitate communication with the athlete and/or their guardian, as the case may be (e.g., in the event of changes to the training schedule, supervision arrangements, etc.). Finally, a record will be kept regarding the days and hours of the athlete's participation in sports activities and their athletic performance during training sessions (where necessary); however, under no circumstances will biometric data be retained. Such data will be retained for a period of no more than five (5) years following the termination or expiration of the relevant contract.

IV.2 Certificate of Fitness for Sports:

Eurohoops Academy will maintain, in both physical and electronic records, the participant's Certificate of Fitness for Sports, which is submitted upon the conclusion and/or renewal of the sports services agreement. Such processing is necessary to safeguard the Athlete's vital health interests and constitutes a legal obligation for Eurohoops Academy. These data will be retained for a period of up to five (5) years following the termination or expiration of the relevant agreement.

IV.3 Audiovisual Material:

By completing the "Athlete Participation Application" form, the athlete's guardian automatically consents to the storage in an electronic archive and the use of audiovisual material featuring the athlete during training sessions. Such material may be used: (a) by Eurohoops Academy staff to monitor the athlete's athletic performance, and (b) for publication online (on the official website or social media pages of Eurohoops Academy and its partners). The processing in question will take place for a period of up to ten (10) years following the termination or expiration of the relevant contract, so that the necessary footage is available should there be a possibility of creating a video documenting the athlete's progress over the years. The guardian, or the athlete themselves (subject to the conditions of applicable legislation), may withdraw their consent by means of a simple declaration submitted to Eurohoops Academy.

IV.4 Electronic updates on Eurohoops Academy news and activities:

By accepting the terms of participation, the Guardian consents to the sending of informational material to the email address provided regarding the news, activities, and programs of Eurohoops Academy and eurohoops.net (i.e., the company "Eurohoops Greece IKE," based at 24 Evrota Street), as well as announcements from partner companies in the context of the Academy's operations and messages from their sponsors. Electronic updates are sent in accordance with applicable personal data protection legislation, and the Guardian may opt out of receiving them at any time via the "unsubscribe" link included in every newsletter received. Data processing for this purpose will continue for a period of up to five (5) years following the termination or expiration of the relevant contract.

IV.5 Other Information:

The guardian or the athlete themselves—subject to the conditions of applicable legislation—has the right to submit a request to Eurohoops Academy at any time for access to, and correction or deletion of, the aforementioned data, or for the restriction of or objection to its processing, or for data portability (transfer) to a third party. In any event, the guardian or the athlete themselves has the right to lodge a complaint with any competent authority regarding any violation of applicable provisions concerning their personal data. It is clarified that, among the aforementioned items, the data referred to in paragraphs IV.1, IV.2, and IV.3 are necessary for the performance of the service provision contract. No automated decision-making and/or profiling of the athlete will take place in the context of processing the aforementioned data. Under no circumstances will the aforementioned data be transferred to a third country (outside the EU) or to an international organization. Regarding the above, it is clarified that Eurohoops Academy acts as the Data Controller. Its full and exact legal name is "Exelixis Basketball Academy Sports Club," and its contact details are provided below. Training sessions and the primary sports facility are located at Anoixi, Attica (1 Marathonos Avenue), where any notifications may be made or requests submitted. The registered office of the Data Controller is located at 35 Pigon Street, Kifisia, Attica. The legal representative of the Data Controller is the President of its Board of Directors, Mr. Andreas Athanasiadis of Periklis.
